### Explanation of Fees

We have listed our common fees to help you calculate costs associated with your care. This does not include any herbs, supplements or prescriptions. Listed are the “usual and customary” fees set by the Oregon Relative Value Schedule (ORVS). Note that for evaluation and management codes, Dr Honeyman spends twice as much time with patients. ORVS recommendations are based on the known costs of operating a medical practice. We are only allowed to adjust our fees if the patient pays at the time of service.

New patient visit example:

- Dr Honeyman: new patient visit for 2 hours; charge is \$350 to \$400
- ORVS codes: 99205 New patient visit for first 60 minutes \$398. Plus 99357 x2 (for each extra 30 minutes) \$173 x 2. ORVS fee for a 2 hour new patient visit comes to \$744

Followup visit example:

- Dr Honeyman: return visit for 45 minutes; charge is \$110 to \$150
- ORVS codes: 99214 a 25 minute visit for \$208. Plus 99354 @\$190.08 for visits lasting 31 to 74 minutes. ORVS fee for 45 to 60 minute return visit is \$398

CPT evaluation and management codes are based on complexity of service rendered: brief, expanded, detailed, or comprehensive level of service. Codes have an associated level of complexity and time. Secondary codes are in addition for visits that have prolonged amount of time.
